- 1. **Approval of the Minutes:** Motion made by Trustee Murray to accept the October minutes as presented. Seconded by Trustee Ferringo. Passed unanimously.
- 2. **Public Comments:** Debra Dion Faust reported that she is looking forward to being able to shelve books again without a mask.
- 3. **Monthly Financial Statement**: Presented by Director Thibeault (see attached). Director Thibeault reported that our spending is on track.
- 4. Library Director's Report presented by Director Thibeault (see attached): Director. Thibeault reported that the internal interviews to replace the vacancy left by Patricia McMahon are going well and he expects a decision soon. Since the Children's Librarian position was just vacated, that has not been posted yet. He also reported that the current Board of Health guidance prescribes "no limitations on in-person meetings or gatherings, however, we are asking that you use your discretion in terms of ensuring that large indoor gatherings are avoided, if possible." For now, the library is focusing on smaller gatherings and perhaps even offering hybrid programs. Director Thibeault offered the library for in person meetings again if the Board was comfortable. There was some discussion, and the thought was to perhaps wait to get through the winter months and the revisit.
- 5. **Old Business** Chairman Sullivan made a visit to the library to hand out Grub Hub gift cards as a thank you to the library staff for all their hard work during the pandemic.
- 6. **New Business:** The next meeting will be December 9<sup>th</sup>; holiday attire is encouraged. Chairman Sullivan talked about having a live tree in the library, courtesy of the Boy Scouts, Troop 62 and perhaps hosting a day of friendship and cheer where kids could make ornaments or other crafts.
